HEALTH & SAFETY POLICY

The Management of H & S at Work Regulations 1999, made under the H & S at Work Act 1974, require employers to assess the risks of activities and take reasonable care of other's H & S. There is also a common law duty to act as a reasonable person in this regard. It is good practice for a Charitable organisation to have one, certainly a written procedure for arranging excursions which leaders should follow. This should include a written Risk Assessment carried out by the organiser/group leader.

The NNAS doesn't have its own premises but operates a Library and arranges Meetings/Lectures, both in other organisations' premises, and it arranges Excursions. Health & Safety issues do apply to Library use and Lectures but these are minimal compared to the Excursion activities.

(1) THE LIBRARY c/o The Norfolk Record Office, Martineau Lane, Norwich

Supervision by the Librarian and the staff of the Norfolk Record Office.

(2) MEETINGS/LECTURES

- (i) The current regular venue for Lectures is the Town Auditorium, Castle Museum which is accessible to those with physical disabilities. There are lifts and wheelchair access. It is fitted with a hearing loop. Refreshments in the Café and toilets are available. The Castle Museum has its own Public Liability Insurance cover.
- (ii) At each meeting the audience should be advised at the outset of the location of the emergency exits and asked to ensure their names have been included in the list at the entrance to the room

(3) EXCURSIONS

Organiser to carry out a risk assessment and complete a Risk Assessment form to identify HAZARDS and RISKS [using NNAS Risk assessment checklist].

Consider what might cause harm/injury (any potential which might lead to claims such as physical features/facilities i.e. car-parking, steps, paths, door steps, stairs, seating, machinery, toilets, washing facilities). Evaluate these as Low, Medium or High risk

Identify what precautions are in place - information, signs, First Aid kit/provision, Fire Procedure information/training.

Identify the group or people likely to be affected i.e. members, volunteers, the public. Make arrangements for their medical needs and any additional support for participants. Provide them with address/phone number of the venue and a contact name plus meeting place and times of activities.

Organiser should warn participants of any known risks in initial invitation to the event.

Organiser Implements H & S policy measures. Take any further measures to minimise harm or damage. Findings should be recorded on a **Risk Assessment Form** (see NNAS Excursions Risk Assessment sheet) and using the RA checklist below.

Organiser follows a Procedure for dealing with incidents & accidents and emergencies (i.e. what to do if a participant becomes unwell or unable to continue; keep a written record of facts, eye-witness account, photograph) notifying the insurer and the NNAS Secretary

Responsibility/Accountability - delegation to the Excursions Hon.Secretary who acts as the Group Leader for Excursions (or appoints A.N.Other) and has overall responsibility for the supervision and conduct of the Excursion
